COMMENTS:

On 2/2/2023 the initial form 4 DOC# 403310828 was approved for abatements on the Pioneer Y18-756 (05-123-48785) with a COA requiring a new bradenhead test, a form 4 outline the current status of the well and pressures that do not exceed 50 psi prior to approval for stimulation. Our belief initially based on the CBL and cementing reports was that it was not sourced from the producing formation and that it was a finite volume of gas. We have conducted multiple abatements under the previous approved form 4. Following each abatement we have seen the shut in pressure not building at the same rate and plateauing at a pressure lower than the previous shut in pressure. Due to limited availability of personnel and abatement equipment, Chevron is requesting approval to install a MESSCO surface kit that will allow us to bleed the remaining pressure off the bradenhead for a more extended period rather than performing abatements on a less frequent basis. During installation of approved surface kits on the other two wells on this pad, this well was also connected to the surface kit unit. After an internal audit, it was discovered we did not have approval for a surface kit utilization on this well. The surface kit ran for 16 days off and on as shown in the chart, from 6/30/2023 to 7/8/2023 and also 7/12/23 to 7/20/23. During a phone discussion with Diane McCoy on August 22, 2023 this situation was highlighted. Gas samples were collected on 3/23/2023 and again on 5/25/2023 for the initial form 4. Analytics have been submitted to the state via form 43. The surface kit will remain on location for the next 12 months and continue to be used as a mitigation strategy to maintain bradenhead pressures below the 50-psi threshold.

Operator will implement measures to control venting, to protect health and safety, and to ensure that vapors and odors from well operations do not constitute a nuisance or hazard to public welfare.2. Bradenhead gas is not to be vented to the atmosphere; any gas from the Bradenhead will be routed to an enclosed tank and/or combustor. Bradenhead pressure shall not exceed 50 psig. Operator will implement measures to get an estimate of the gas flow rate and/or volume from the bradenhead.3. Within thirty days of 09/07/2024, conduct a bradenhead test, submit a Form 17, and submit a Form 4 Sundry that summarizes current well condition. The sundry should include details of the future plans, sample analysis interpretation, bradenhead test description, and the flow rate information and pressure data.4. Shut well in for at least seven days to monitor and collect data to characterize build up pressures then conduct a new bradenhead test and submit the Form 17 within ten days of the test.5. If a sample has not been collected from surface casing within the last twelve months collect bradenhead gas samples and production gas samples for laboratory analysis. Sampling will comply with Operator Guidance - Bradenhead Testing and Reporting Instructions, Appendix A: Liquid and Gas Sampling. Copies of all final laboratory analytical results will be provided to the COGCC within three months of collecting the samples.
