The tubing and pump jack was removed from this well for the Coal Draw #3 well. Production in this well had dropped to practically nothing and water was coming in. From December 4 to 14 this well was drilled deeper to 4102' and no additional oil was encountered. It was therefore abandoned in the following manner:

- A. An unsuccessful attempt was made to pull the 5 1/2" casing (3150').
B. Installed 30-sk cement plug from 3250' - 3100' across bottom of casing.
C. Installed 20-sk plug across perfs in casing at 2375' to 2225'.
D. Installed marker in 5-sk cement plug at surface.
