On 3/19/97 we plugged the Newton 16A because of a fish in the hole at a depth of 2150'. This well is replacement well on the same well pad but located 50' west of the 16A well. Twin Arrow, Inc. proposed to set 60' of Surface 7" casing with the 7" well being cemented to surface. A 6 1/8" hole will be drilled to the base of the mancos, 4000' or to the first commercial oil zone which ever is shallower.
