Appears the Operator has performed interim reclamation activities to reduce disturbance areas only needed for production operations. Much of the interim area consists of annual, weedy growth. Due to the autotoxicity behavior of alfalfa, new alfalfa may or may not establish into an existing mature stand of alfalfa. Operator could determine a grass seed mix with the surface owner to supplement alfalfa.
