### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the cut and capping of isolation valves associated with previously P&A'd LILLI UNIT 16-7. These valves were used to isolate the injection well from the gas gathering system.

Five (5) grab soil samples were collected at the base of the excavation and the areas showing the highest degree of impact during field screening activities at the wellhead excavation. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, one soil samples was analyzed for metals in soil per COGCC Table 915-1. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

A partial site assessment was conducted to delineate soil impacts on March 30, 2022. A total of five soil borings were advanced in the area of impacts. Soil samples were collected and analyzed for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and pH, EC, SAR, and boron. One of the five soil borings was converted to a temporary groundwater monitoring well and installed at 6' bgs. Groundwater was not encountered in the monitoring well.
