All stained soil was cleaned up and properly disposed of immediately. See attachments for documentation of contact to ECMC EPS. See attachments for disposal manifest. The large area of stained soil was from a 3 sided drill cuttings disposal storage bin. The stains in that area are from the solid controls loader tracking in and out of the cuttings bin. A little cuttings with OBM gets stuck between the tire lugs then proceeds to fall out on pad. This area and gets continual attention and is continuously being cleaned up. Some of the other small stains appeared

to be from drips from trucks of motor oil and hydraulic oil. All stains were significantly less than a BBL. All the stains were on the surface of the pad. The stains were cleaned up immediately with a hydrovac truck that was on site.
