

Dear Mr. Eilts:

It is the understanding of the Colorado Oil and Gas Conservation Commission that the Marion W. MacKinlay #1 (sese Sec. 23, T6N-R87W, Routt County; API No.: 05-107-5206) is operated by John Eilts (DBA: Allie Oil Company) since December 1992. In order to complete our records the COGCC requires the following:

1. Submit Form 4--Sundry Notice per Rule 305 and Rule 317b(1) updating the status of the well; the last update indicated the well as shut in.
2. Submit Form 10--Change of Operator per Rule 310 indicating that Allie Oil Company is the operator of record.
3. If the well is not in production, the COGCC requires that you arrange to schedule a mechanical integrity test (MIT) per Rule 324b,c,d with Jamie Adkins, COGCC Field Engineer, by November 15, 1995. He can be reached at (970) 858-7521.


In a separate matter, please submit to this office the original individual plugging bond for the Bear Victor #16-11 (sese Sec. 11, T6N-R87W, Routt County; API No.: 05-107-06041). The COGCC also requires that you submit a Form 4--Sundry Notice status update and schedule a MIT; see Nos. 1 and 3 above.

In order to complete the records for the Tow Creek #7-14 (swne Sec. 14, T6N-R87W, Routt County; API No.: 05-107-06050) the COGCC requires the submission of a Form 4--Sundry Notice status update and the scheduling of a MIT; see Nos. 1 and 3 above.

The COGCC is requiring that Allie Oil Company provide by November 15, 1995 a status update or the final plugging and abandonment notice on Form 4--Sundry Notice and a schedule showing when the wells will complete a MIT. In order to assist you in filing the required forms, the COGCC is providing you a copy of the current Rules and Regulations of the Colorado Oil and Gas Conservation Commission. Blank forms are located near the back.
