Laboratory analytical indicated a historical release occurred at the Hansen BC O-64N67W 1 NESE decommissioned tank battery. One soil sample exceeded ECMC standards for 1,3,5-trimethylbenzene at 0.013 mg/kg, 1-methylnaphthalene at 0.0692/kg, and 2-methylnaphthalene at 0.112 mg/kg. This release was within the municipality of Milliken, Colorado, and within Mule Deer Severe Winter Range high priority habitat.
