Unused/disconnected equipment near wellheads. Please remove to comply with Rule 606. (Corrective Action Date: October 5, 2023) See attached photos #2, 7.</p> <p>2. It appears the north gas meter has not been annually calibrated. Calibrate gas metering equipment annually to comply with rule 430.d.(1).
