Comment:

This location does not comply with Rule 1004. During this inspection, Staff observed that a cattle guard remains at the entrance and the reclaimed areas of the location dont appear to be progressing towards Rule 1004 regulations and standards. There was evidence of undesirable vegetation (e.g kochia) and CO Listed Noxious weeds (e.g. scotch thistle, common mullein, and field bindweed) growing throughout the location and areas of bare/exposed soils. Additional reclamation activities are required. Refer to attached inspection photos.

Corrective Action:

Comply with Rule 1004. Location will remain out of compliance until the corrective action has been resolved.
