INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

The Marick Location, and associated Marick A-1 Pits (North and South) and Tank Battery will be decommissioned in accordance with ECOM Rule 911.a. and ECOM Rule 913.c.(1). Soil and groundwater (if encountered) samples will be collected and submitted for laboratory analysis to determine if concentrations and values are in compliance with ECOM Table 915-1. Visual inspection and field screening of soils around the tank battery and the N&S Marick A-1 Pits will be conducted during sampling activities. The topographic Site Location Map showing the geographic setting of the site is provided.

Following facility decommissioning activities, discrete soil samples will be collected from the surfaces and excavation areas underneath the separator, three above ground storage tanks, and within the north and south pits. In the absence of apparent impacts, soil samples will be submitted to an accredited laboratory for analysis for benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, total petroleum hydrocarbons (TPH) - gasoline range organics (GRO:C6-C10) by USEPA Method 8260D, TPH - diesel range organics (DRO:C10-C28) and oil range organics (ORO: C28-C40) by USEPA Method 8015D, pH, specific conductance (EC), sodium adsorption ratio (SAR) by saturated paste method, and boron by hot water soluble soil extract method. 2 background samples will be collected at locations of comparable, nearby, non-impacted native soil. Proposed soil sample locations are provided.

If groundwater is encountered during facility decommissioning activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene, using standard methods appropriate for detecting the target analytes in ECOM Table 915-1.
