Comment: On 9/29/2023 Wapiti Operating had a release at approximately 1300 hrs. It was estimated 13,000 barrels of produced water was released. The line was isolated and immediately repaired. During the site inspection, ECMC determined the waters from the release impacted an ephemeral drainage identified as waters of the state approximately 100 feet east of the spill.
