Comment: This location does not comply with Rule 1004. During this inspection, Staff observed that a cattle guard and road base material remain on the former tank battery location. Undesirable vegetation (CO List C Noxious Weed-Cheatgrass; russian thistle and kochia) were evident throughout the tank battery location, access road and well location. The reclaimed portions are not progressing towards Rule 1004 standards and are not reflective of adjacent reference areas. Refer to attached inspection photos.
