Comment: Operator completed COAs upon the Plugging and Abandonment of the Patti-32-29. Reclamation work commenced 6/26/23 and was completed on 9/13/23, delayed by daily monsoon rains. Road repairs were completed on the Kelsey Court Access side, and up to the locked out gate (denied access by landowner) on the CR95 side.
