Comment: Operator has conducted repairs from gully erosion on the southeastern ditch BMP that is directed to a retention pond. At the time of this inspection the retention pond is functioning properly and no observed sediment discharge from the location.

There is observed and continued rill erosion on the western cut slope. Operator continues to try and seed the cut slope which is not sufficient due to the lack of establishment. Staff would recommend additional BMPs like erosion control blankets.

Corrective Action: Comply with Rule 1002.f.(2)C.
