Form 6S has not been approved and remains in process.</p> <p>There is no evidence that reclamation was ever performed.</p> <p>The access road has not been reclaimed and unmanaged weeds observed throughout the access road.</p> <p>The location has not been recontoured, debris remains on location, all guy line anchors remain, and unmanaged weeds observed throughout the location.</p>	
Corrective Action:	<p>Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS.
