
Dear Sirs:

Dear Mr. E. W. Guynn:

With regard to your letter of January 5, 1978 as it relates to Well Nos: 51 and 51X Federal.

After checking our files, dead and active in the Rangely office and Denver office we find that Well 51 according to our files should have been listed as 151 M instead of 51. This Well was drilled by Gulfland Inc., and assigned to our company in May of 1970, therefore we do not have any of the information on this Well except that the "M" stands for the Well being drilled to the Morrison formation. We have a survey plat listing 151 M and 51X properly surveyed and dated September 16, 1969. We are inclosing two copies.

The Sundry Notice of intention to abandon Well 151M as of May 1976, this Well was abandoned as of that date according to Regulations by Utah-Colorado Casing, Pulling Company of Vernal, Utah. A proper marker was placed and cemented as required with the following information: Well 151M, Section 11, SENE, T I N, R 102 West, Lease D-032682-A, Rio Blanco County, Colorado.

As to the Sundry Notice to abandon 51X dated February 18, 1975 we have no record of this abandonment notice, however we do have a Sundry Notice dated November 7, 1977 which indicates 51X to be located 2100' FNL 1950' FEL, SWNE, section 11: T I N, R 102 West. This Well has been re-measured and found to be exactly in the correct location and Well 151M was also re-measured and is in the correct location. Where the number 51 originated I do not know except that perhaps as you will note on the survey plat the dot in front of 5 may have blurred the one.

According to our records and all information we are able to locate and authenticate Well 151M is in the proper location, was properly abandoned in May of 1976. Abandonment approved by the department and all information forwarded to the department.




