Comment: Operator appears to have performed some final reclamation activities; removing gravel on location and some seeding activity. However bare soil dominates the well location and the access road remains incised and weedy.

Corrective Action: _____ Date 10/17/2023

Comply with Rule 1004. Reseed disturbance areas using seed mixture requested by surface owner, or prescribed by local NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.

Operator will reclaim the access road by regrading and reseeding in order to meet Rule 1004 standards.
