This site is part of an ongoing complaint from the landowner. Both landowner and operator are being consulted for the duration of the complaint. This location has an ongoing groundwater project associated with it (project number 23968). The complaint is regarding reclamation progress or lack thereof. Large bare areas are present surrounding the horse iron wellheads. Several soil stock piles are present as well. Groundwater is present in the open cut and capped wellhead excavations. Current cattle fencing at the wellheads is sufficient. ECMC environmental staff will continue to monitor this location as the remediation project progresses and ECMC reclamation staff will be consulted throughout as well.	robinsotl	10/27/2023
