The pit #102744 is a partially buried vessel made of steel used to store oil producing from the well and is evacuated of its contents on a regular basis. It is currently in use and there is no change of status for this

equipment. This response applies for identical CA in previous FIR #699107428.

COGCC Decision: **Not Approved**

COGCC Representative: Pit #102744 is currently listed as an unlined and netted pit with status "unknown" and a status date of 9/23/1999. Pit is mapped 110' away from the actual pit location. This does not match Operator description in this FIRR, nor on the ground conditions.
