Hi John,

Your waste is approved for disposal at Phantom Landfill. The profile number for the solid waste is P-20220303-A and the profile number for the liquid waste is P-20220303-B.

We have next Wednesday, March 9 open. We would probably be able to be on site around 930. We can send a roll off to pick up the soil and a vac truck and trailer to get 4500 to 5000 of the liquid. We will then send a vac truck back to get the remaining 2200 to 2700 gallons of liquid.

The cost is \$125.00/hour for the trucks. The liquid is \$0.50/gallon, and the soil is \$0.50/ton.
