Corrective Action:	<p>This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 07/26/2019.</p> <p>Recontouring appears to have been done on the location however seeding and weed management have yet to take place. The location and access road are dominated by russian thistle and cheatgrass.</p> <p>The tank battery location is also dominated by weeds (kochia, russian thistle and cheatgrass) and bare soil.</p> <p>Comply with Rule 1004. Reseed conduct weed management on all disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p>	Date 11/17/2023
