Date of work AFTER AUGUST 1, 1974

It is proposed to plug and abandon this well as follows:

1. Rig up and pull tubing.
2. Set 100' cement plug through a retainer, set +50' above 7" casing shoe.
3. Set a 2-3 sacks cement plug on top of the retainer.
4. Pump 150 sacks cement down the 7"-surface pipe annulus.
5. Lay a 30' cement plug in the top of the 7" casing.
6. Weld a plate over casing head and install marker.
7. Remove or bury cement pumping unit foundation and "dead men".
8. Clean up all loose pipe, fittings, debris, etc. from location.
9. Scarify non grassy areas and plant seed (8-10#/acre), avoid further disturbance of surface conditions.
