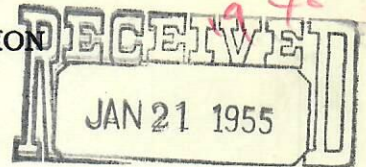

4. Hole filled w/mud to 562'. Set plug 562' to 20' w/33 sacks cement.
5. Set 4" marker w/12 sacks cement from 20'.
6. Location graded.
