General Comment:

This is an environmental inspection of KP Kauffman's (KPK) Johnson 32-30 well (API 123-16238). In response to operational information provided during plugging and abandonment activities - ECMC has required a Form 27 be submitted for a stray gas investigation by close of business 12/5/2023; this form 27 should include plans to sample all Upper Pierre wells within 1 mile and all wells within a 0.25 mile by 12/15/2023.

ECMC has requested contact information for the on location wildlife biologist (Note: previously required by CPW on Thursday November, 30 - See attached email correspondence).

Upon arrival ECMC Environmental Protection Specialist, Laurel Anderson, spoke with a KP Kauffman crewman who indicated a wildlife biologist was not on location.
