A site investigation was conducted pursuant to COGCC Rule 911 at the PROSPECT T4N-R64W-S26 L02 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumpline(s) of any separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Five background soil samples (BKG01@1', BKG02@4', BKG02@6', BKG03@4', and BKG03@6') were collected from areas not impacted by oil and gas development and analyzed for Table 915 Soil Suitability constituents (pH, EC, SAR, and Boron) and Table 915-1 metals. Background soil samples were reported with naturally elevated concentrations of Arsenic for each background sample.

Before excavation of impacted soil, soil borings will be installed to delineate the vertical and lateral extent of soil impacts at the location. Confirmation soil samples will be collected and analyzed for the full Table 915 suite. If groundwater is encountered, the soil boring(s) will be improved with temporary PVC monitoring wells and sampled for Table 915 constituents in groundwater. Should no additional active remediation be required following source removal at the location, a no further action (NFA) determination will be requested within 90 days following laboratory confirmation of the removal of impacted soils with respect to the applicable Table 915-1 screening levels at the site. If groundwater impacts are observed, an NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to ECMC in a supplemental Form 27.

Spill ID 484887 reported for the Prospect CO-64N64W 26NESW facility (329942) was submitted under remediation ID 27001 by error. The aforementioned spill should have been reported for the Prospect CO-64N64W 26 NENE facility (329937) and remediation ID 27801. If approved, further work done on Spill ID 484887 will be completed under remediation project # 27801.

Noble Energy Inc. requests that further soil sampling at the location includes only analysis for Table 915-1 organic compounds and SAR. Facility decommissioning soil samples were not reported with exceedances for ECMC Soil Suitability for Reclamation constituents except for SAR. Additionally, background soil samples indicate that Arsenic is naturally occurring in the native soil at the location. If approved, additional site investigation and excavation confirmation soil samples will only be analyzed for Table 915-1 organic compounds and SAR.
