Dear Mr. White:

This letter will confirm my telephone conversation with you on May 17, 1982 regarding a claim on the subject bond. Please be advised that your Principal, Wyco Petroleum, Inc., drilled the subject well to a depth of approximately 6120 feet, subsequently was unable to pay for certain services and material, and recently filed for bankruptcy under Chapter 11.

Wyco Petroleum, Inc. did not plug and abandon the well and a field inspection will be made to determine the amount of work required to plug and abandon the well according to Rule 331 of the Rules and Regulations of the Oil and Gas Conservation Commission. Every effort will be made to keep abandonment expense within the limits of the bond, which is in the amount of \$5,000. It is the policy of this agency to engage an abandonment contractor, proceed with the required work and after completion, forward the contractor's invoice to the bonding company for payment. All work will be approved and supervised by this office.

This letter is to advise you that it constitutes a claim on Bond # S 838844, and authority for this action may be found in the Oil and Gas Conservation Act under 34-60-105 and 34-60-106, C.R.S. 1973, as amended.
