Plan to drill 13-3/4" hole to approximately 70' and set 60' of 9-5/8" surface pipe. Drill 8-3/4" hole with mud to a depth of approximately 3300' and set 7" casing. Drill 6-1/4" hole with air to a depth at which commercial oil production is encountered or the Carlile shale (approximately 5100') whichever occurs first. If productive will complete as oil well.

*Copies of survey plats will be mailed prior to commencement of drilling.
