## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures taken to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to summarize ongoing assessment activities conducted during the plugging and abandonment of the Engstrom 15-34 wellhead and the removal of the associated flowline, as proposed in the Form 27 Initial dated January 24, 2023 (Document No. 403299975). Assessment activities have not yet commenced at the site.

The flowline will be permanently removed. The off-location flowline system pre-removal notice was submitted under Form 44 Document No. 403280962. In accordance with ECOM Rule 911.a., soil samples will be collected and submitted for laboratory analysis of the ECOM full Table 915-1 to determine if soils are in compliance. Visual inspection and field screening of soils around the wellhead(s) and associated pumping equipment will be conducted during sampling activities. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1. Proposed soil sample and screening locations are provided on Figure 2 and 3. Soil vapor screening will also be performed around the wellhead. The Form 44 is attached.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Following wellhead cut and cap operations, soil will be field screened at the wellhead, separator riser, and associated flowline. If impacted soils are encountered, a waste characterization soil sample will be collected from the areas exhibiting the highest degree of impact based on visual, olfactory, and/or field screening observations and analyzed for all analytes listed in ECOM Table 915-1. In the absence of apparent impacts, a soil sample will be collected from the base of the excavation adjacent to the wellhead, adjacent to the wellhead riser, and adjacent to the separator riser and the areas most likely to have been impacted during the operational life of the flowline. Soil samples will be submitted to an accredited laboratory for analysis using standard methods appropriate for detecting the target analytes in ECOM Table 915-1. Please refer to the Form 27 Initial (Document No. 403299975) for more details.

If groundwater is encountered during facility decommissioning activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, using standard methods appropriate for detecting the target analytes in ECOM Table 915-1.

A waste characterization profile will be developed utilizing the initial sampling results. All analytes detected in the initial sampling will be included in the established waste characterization profile and applied to excavation confirmation sampling. Once established, only analytes included in the waste characterization profile will be applied to additional required sampling. Following cut and cap operations a soil vapor survey will be conducted adjacent to the former wellhead location utilizing a maximum of five (5) soil vapor points. The proposed soil vapor point locations are illustrated on Figure 2. Please refer to the Form 27 Initial (Document No. 403299975) for more details.
