	<p>Operator performed final reclamation activities during Fall 2016, except for an area around a meter house and the entry way off SH392.</p> <p>Gravel, gates and a cattle guard have not been removed at the entry way off SH392. The gates and cattle guard serve no purpose in its current state.</p> <p>Unmanaged weeds were observed throughout the tank battery, access road and well location. Russian wildrye appears to have been planted, which is an introduced species not reflective of reference areas. Russian wildrye appears to be spreading out onto reference areas. Russian wildrye's bunch grass vegetative growth form differs from reference area vegetative growth. Refer to the attached inspection photos.</p>	
Corrective Action:	<p>Comply with Rule 1004 to remove the remaining gravel, gates and cattle guard; perform weed management and reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil.</p> <p>Operator shall provide the approved surface owner seed mix before planting Russian wildrye again.</p> <p>Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p>	Date <u>12/14/2023</u>
