Well plugged and abandoned as follows: pulled rods and 2-3/8" tbg. Plugged back w/sand from 4896-4845'. 4-1/2" csg free at 3300'. Pld 3 jts and pmpd 35 sx (100') cmt plug, 1/2 in and 1/2 out of stub. Pld 102 jts (105 total). Laid 15 sx cmt plug across btm of 8-5/8" csg. Cut off 8-5/8" csg 3 ft. below gr. level and placed 10 sx cmt at surface. Well plugged and abandoned 12/11/76.
