Comment: **There is an open wellbore at the location that is covered with a plastic bucket that needs to be immediately covered to prevent entry for safety concerns. The open wellbore needs to be plugged and abandoned. There is exposed electric lines and multiple open pipe risers. All unused risers and utilities need to be removed. Unused areas of the location must be reclaimed per 1004 Rules. Corrective action back dated to when all reclamation should have been completed. Corrective action will remain out of compliance until completed.**
