Limited visibility due to snow cover. Desirable perennial vegetation was not apparent; vegetation that was evident were Undesirable and Weedy Plant Species such as Kochia.

Form 27(s) #402854372 for decommissioning of the O&amp;G facility was approved with NFA on 11/29/2021.

It was observed in this inspection that the that the excavation at the P&amp;Ad well has not been backfilled. Additionally, the livestock panels at the wells have not been adequately secured/closed to prevent wildlife access to the wells and excavation area.

Corrective Action: Maintain fencing to prevent unauthorized access by people, livestock or wildlife.
