INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

The ECMC Orphan Well Program has plugged the Ferguson (OWP) #1 well and decommissioned the wellsite in May 2023. Soil samples were collected in accordance with the Initial Form 27 for the project and COGCC Rule 915.e(2)B. One soil sample was collected from the site at the wellhead excavation. No production equipment and/or flowlines were located at the wellsite at the time of plugging and site decommissioning. All samples were submitted for laboratory analysis of COGCC Table 915-1 constituents. Additional information regarding the analytical results is described in the Site Investigation Report section below.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

All areas suspected of having potential impacts, including the wellhead, associated flowline(s) (if present), and production equipment (if present), were visually inspected and field screen with a PID. Using these observations and field screening results, soil samples were collected from areas most likely to be impacted. One discrete soil sample was collected from the wellhead excavation. No production equipment and/or flowlines were located on the wellsite at the time of plugging and site decommissioning. All samples were submitted for laboratory analysis of Table 915-1 constituents. The attached project map provides the location of all samples.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

No groundwater or pathways to groundwater were discovered during the plugging and decommissioning activities. As such, no groundwater samples were collected for this project.

No surface water was discovered in the vicinity of the wellsite during the plugging and decommissioning activities. As such, no surface water samples were collected for this project.

Background soil samples have been collected from nearby non-impacted native soils within the Red Mesa project area to establish background concentrations. The background samples have been analyzed for ECOM Table 915-1 constituents and indicate Arsenic values above the ECOM Table 915-1 standards. It is requested that background concentration be considered when evaluating the site for final closure. A background soil table is provided with the attachments.
