Comment: Appears the Operator has performed some final reclamation activities and has managed some areas of the well location, with the evidence of the location being mowed. There was some germination of perennial grasses however weeds (russian thistle, and cereal rye) dominated the well location.

Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.
