After setting surface casing, well was drilled to a total depth of 5155' and electric logs were run. One Drill Stem Test was also run. Since there were no significant shows of oil or gas, well was plugged and abandoned as follows:

35 sack cement plug from 4955' to 5060'
25 sack cement plug from 100' to 150'
10 sack cement plug from surface to 30 feet.

Hole was filled with heavy mud as requested by Commission Representative on 11/21/85.
