Comment:	There are various supplies and debris stored inside the dilapidated storage shed which appears to be an extreme fire hazard adjacent to the tank battery. There are chemical containers, parts, debris, trash, and various other materials laying on the ground. The stored supplies does not appear to have been used for a long duration of time and is not in use. All unused supplies, containers, materials, and equipment must be removed.

Comment:	There are tall undesirable weed debris around the perimeter of the location that needs to be controlled and removed. The debris is up against the electric fence which is a fire hazard.

Comment:	The storage shed adjacent to the tank battery is in disrepair. Part of the roof has blown off from the shed and there are other loose rattling metal pieces that may fall off.
