This Site was drilled and sampled in September 2023 to delineate inorganic impacts identified in the original excavation. One boring was advanced in the excavation area (SB01). Analytical results from these borings indicate that the SAR impacts have been delineated. Also, additional background samples were collected in June 2023. Please see the attached Analytical Data, Table, Figure, and Boring Logs.
