In accordance with Rule 218.b.(1-7) Transfer of Operatorship Intent, Peterson Energy Operating Inc (Peterson), Selling Operator, would like to inform the Energy & Carbon Management Commission (ECMC) that Peterson will be transferring select assets to Buying Operator, Impetro Resources LLC (Impetro). The transaction is to be considered confidential and any other associated information confidential pursuant to § 24-72-204(3)(a)(IV), C.R.S. Peterson and Impetro submit this letter of attestation and associated documents to notify the ECMC of the transfer of assets.

Per Rule 218.a.(1), included as Attachment A is the Transferable Items list associated with this transaction. Both Operators agree to the transfer of operatorship of the attached list of Transferable Items and that the attached list of Transferable Items is complete. Impetro has financial assurance in place to cover the bonding requirement to acquire these assets to their operatorship per Rule 702. The transfer is anticipated to take place November 10, 2023. Impetro will be assuming responsibility for all Transferrable Items associated in this transaction. Any Items not transferring in this transaction will remain the liability of Peterson and Peterson will retain compliance with Commission rules.
