Dear Mr. Skaer:

In reference to your letter of September 16, 1986, we appreciate your correction of the location of the Federal A-1 and A-2 wells.

We sent you two approvals to plug these wells on June 25, 1986. Copies of these approvals are included. They are on Sundry Notice Forms (3160-5). The letter sent to you should have read that approval to plug was given more than two months ago.

In your request to plug these wells, dated June 3, 1986, you stated that plugging operations would commence around June 20, 1986. You also stated that you would appreciate receiving approval as soon as possible so you could schedule the work. Our demand letter, dated September 10, 1986, was based on the information given in your well plugging request.

For the reasons stated in your letter of September 16, 1986, we extend the plugging dead line for these wells to January 1, 1987.

This letter is to be considered an order or instruction of the authorized officer. Failure to comply with the requirements as set forth by the letter, or to furnish any requested information will be in violation of 43 CFR 3163.3(a) and will result in the issuance of an Incidence of Noncompliance and will be subject to any assessment that may apply. If you feel additional time will be necessary to comply with the requirement, you should immediately contact this office with reasons and justifications, and an extension will be considered.

Any instruction, order, or decision issued under the regulations in 43 CFR, part 3160 - Onshore Oil and Gas Operations are subject by request of the operator/lessee to a Technical and Procedural Review in accordance with 43 CFR 3165.3, or may be appealed in accordance with 43 CFR 3165.4.
