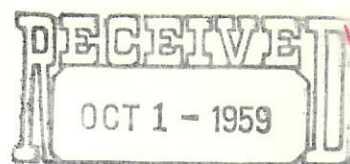

Unless operations are commenced within 180 days after the date of approval hereof, this approval to drill will become null and void.

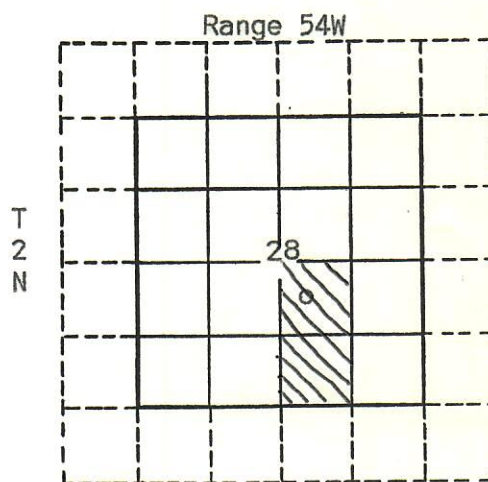
