1002b. SOIL REMOVAL AND SEGREGATION Fail

Comment As the previous inspection noted, it was unclear why the Topsoil Protection Plan stated there was not a plow layer for this location and why only six inches of topsoil was salvaged because there is an obvious ag land use prior to construction. Refer to the photos.

Operator response was that the landowner did not want to salvage the plow layer due to underlying infrastructure. ECMC staff communicated that landowners cannot waive rules without an approved variance from the Commission. There is no approved variance on file. A third-party pipeline inspector inspected the line on 4/14/2020.

Operator failed to conduct the geotechnical topsoil evaluation per their own Plan, but is currently in-process of completing the required analysis.

Corrective Action Operator shall provide the following:
 1) Submit the test pit location information as the Exploration Plan of the Geotechnical analysis via Form 4 Sundry Notice to the attention of Chris Binschus.
 2) Submit soil horizon thickness and evaluation data provided in a Geotechnical report via Form 4 Sundry Notice to the attention of Chris Binschus.
 3) Provide the depth of the 8" crude oil gathering line (shown in Photo #3) and justification for not salvaging the plow layer. Note- the landowner was conducting agricultural practices after the 8" crude oil gathering line was installed, likely tilling to a depth of 12" (plow layer).
