TEP will make every effort to perform legitimate corrective actions within reasonable and attainable time frames, but we cannot comply with dates that are expired before they have even been sent to us.

ECMC's statement that the "Corrective Action dates provided will either be back-dated to when Operator should have been in compliance(?), or when Operator was initially observed to be out of compliance; the 'Date of Discovery' is being provided as the corrective action date for all new observed compliance issues" is inconsistent with the concept behind the Corrective Action Matrix that ECMC has implemented for years. The purpose of the Corrective Action matrix is to set reasonable time frames that would allow operators to accomplish various types of corrective actions based upon the level of urgency and potential risk associated with the CA. ECMC staff has also claimed that "... the Factual Review Requests are not a forum for the Operator to dispute the corrective actions." Again, this contradicts the purpose of the "Factual Review Request" option. The FIRR is the ONLY "forum" for an Operator to dispute a Corrective Action. TEP is simply requesting a fair and reasonable amount of time to complete the task.

For documentation purposes, TEP will continue to dispute any Corrective Action date that is assigned by ECMC staff that is impossible / unattainable to meet.
