On Tuesday, 01/30/2024, Inspector Kirby Burchett, conducted a follow up field inspection at KT Resources LLC on the WRD Unit 32-12 well, Location #316278, in Rio Blanco County, Colorado.

This location is within or in close proximity to Parks and Wildlife (CPW) District with High Priority, NSO, Density, and Other Consultation Habitats.

Follow up inspection in response to compliance issues observed during Insp. #702501131 on 4/11/23. Original due dates remain on unresolved Corrective Actions:

1. Stormwater BMPs not implemented or maintained. (Unresolved)
2. Gas meter calibration card not conspicuously posted. (Resolved)
3. API Number missing on tank battery sign. (Resolved)
4. Chemical tank labels illegible or missing. (1 of 2, Unresolved)
5. Chemical tank containments full of liquid. (Resolved)
