While there during normal operations the following compliance issues were observed:

1. Random debris.
2. Unused equipment storage.
3. Unmarked and illegible container labels.
4. Equipment open to wildlife.
5. Leaking equipment and stained soil.
6. No visible display of gas meter calibration.
