Evidently a pumper had dripped a little oil off his gauge tape while gauging the tank. Cleaned old oil stain from side of tank.

In addition, the inspectors commented under "General Comments" that there were 2 active remediation projects on this site. One was taken care of by a previous operator years ago and the other refers to a pit owned by the state of Colorado. It is my contention that these general comments were not the responsibility of McCartney and should have not been listed on this form.
