On 02/01/2024 at approximately 11:03 hours, I, Compliance Specialist, Wayne Smelser
Conducted a follow up inspection at CAERUS PICEANCE LLC FEDERAL 20-10 (PN20) Pad.

Location # 334682 in Garfield County Colorado.

Please refer to inspection 708902869 conducted on 01/23/2024, previous corrective action has not been completed.

Location is within High Priority/Density/Black Bear Habitat areas.

Location is in close proximity to Rule 411a Surface Water External Buffer.

While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1. Equipment - Flowline heating insulation open ended/wildlife hazard/available for entry by wildlife with a CA date of 01/30/2024
2. Housekeeping - Barbed wire laying on ground/wildlife hazard with a CA date of 02/07/2024
3. Equipment - Rupture disc vent line lacks cap with a CA date of 02/11/2024
4. Stormwater - Lack of stabilization/compaction/insufficient BMP's on lease road with a CA date of 03/05/2024

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
