Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

## OPERATOR COMMENT

Noble Energy (operator) is requesting to leave concentrations of pH outside the range of the Table 915-1 standards in place based on land use and complementary analytical data.

pH concentrations outside the Table 915-1 standards exist in previously and currently uncultivated rangeland. pH, observed in two discrete locations, is the only constituent across all samples analyzed not in compliance with Table 915-1 standards. This suggests that since organic and inorganic impacts, barring pH, were not observed site wide it is likely that pH concentrations outside the Table 915-1 concentration range are related not to a petroleum release but to the chemical variability of native soil at the Patriot tank battery location. Therefore, the operator proposes to leave pH in place.
