Comment:

The beginning of the access road has not been reclaimed and the fence has not been reinstalled to the original position. There is a two track road that will need to be decomapcted. The location has not established a sufficient perennial vegetaion cover and consists mostly of undesirable weeds. It does not appear that perennial vegetation is progressing and additional seeding will need to be performed before the upcoming growing season. There has been mowing performed since previous growing season. Ongoing mowing should be performed throughout the growing season to prevent competitive weed growth. Continue to monitor and maintain the location until the final reclamation requirements are achieved.
