On Wednesday, 02/21/2024, Inspector Kirby Burchett, conducted a routine field inspection at Antler Energy LLC on the Ptasynski 3 well, Location #312952, in Moffat County, Colorado.

This location is within or in close proximity to Parks and Wildlife (CPW) District and High Priority Habitat area with Density and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal production operations the following compliance issues were observed:

1. Random debris.
2. Well sign lacking required information.
3. Unmarked anchors.
4. Gas meter calibration not up to date.
